- (a) The children of citizens, who are displaced from Jammu and Kashmir to any part of India or from unsafe border area of Jammu and Kashmir to a relatively safer place in Jammu and Kashmir from 1990 onwards due to terrorist activities; or
- (b) The children of officers belonging to Indian Administrative Services (IAS) or Indian Police Services (IPS) or Indian Foreign Services (IFS) and children of staff belonging to military and paramilitary forces transferred to Jammu and Kashmir to combat terrorist activities and joined the post on or before the last date for submission of application for admission; or
- (c) The children of staff and officers of Jammu and Kashmir Police engaged in combating terrorism:

The eligible candidates will submit the application along with required self-attested photo copies of the documentes in person or by Registered Post, **upto 15<sup>th</sup> August, 2018 to Director, Higher Education, Maharashtra State, Central Building, Pune 411 001.**


**Documents to be submitted:**

3. CAP Appliation Form duly signed by the Candidate.
4. Qualifying Examination Marks Memos.
5. Photo copy of the filled in Proforma J/K/L/ as applicable.\*
6. Self Attested Photo copies of the document as per Government Resolution No.- TEM 8096/(7488) TE 1 Dated- 24<sup>th</sup> June 1996 Appendix "A" (G.R. Dated 24<sup>th</sup> June 1996 enclosed with this Notice)

Applications received after the due date will not be considered. Incomplete applications will be rejected. The decision of the Nodal Officer in this regard will be final. Applications without self-attested specified enclosures/documents mentioned above will be rejected.

Directorate of Higher Education will allocate the colleges to the candidates as per Merit and Options given by candidate and issue orders to that effect. The candidates will report to the Colleges allocated to them and get the original documents verified and confirm the admission by paying the specified fees.
